Applicant agrees that venue for any lawsuit concerning an account which has become delinquent, will be fixed in Victoria County, Texas.
2. If Applicant becomes delinquent in the payment of any amounts owed to Company, Company reserves the right to change the Terms and Conditions of credit to Applicant at any time at Company’s sole option, without notice, as allowed by law.
3. As permitted by law, if any check given to Company as payment on account is returned unpaid by Applicant’s bank, Applicant will be charged a reasonable returned check fee.
4. Applicant agrees to notify Company of any change of ownership of the Applicant or of any change of financial status which renders or threatens to render the Applicant insolvent and further agrees to be liable for all purposes should the undersigned fail to comply with said notification.
5. Applicant agrees that Company may give information regarding the handling of Applicant’s account to credit bureaus or others who may lawfully receive such information.
6. Company may also obtain information or give information to others when Applicant has: (1) Not paid on time; (2) Company believes there is a question of illegal or improper activity; (3) Company receives legitimate request from a government authority or (4) Company is required to do so by law.
